In India, the Government has taken steps to introduce dispute redressal mechanism by way of Consumer Protection Act to protect consumers from unethical practices of manufacturers and traders.

However, this is largely unknown to many people irrespective of the fact whether they are educated or uneducated. Education is a lifelong process of constantly acquiring relevant information and knowledge. Consumer education is an important part of this process.

The consumption patterns are changing fast and the students of today are very clear on their choices regarding food, clothing, cosmetics, fancy articles and accessories. It becomes important for students to check details (for example: labels) before buying products. Students can be taught to stop wisely and a few simple precautions will ensure that they choose the right product at the right prices. These factors assume vital importance as students of today are citizens of tomorrow.

Consumer education also involves environmental education as it deals with the importance of conserving (natural resources) and sustaining (recycling and reusing) the environment, including the direct health effects of environmental pollution and toxic products on consumers.

**2.1) D.K. District Consumer Federation**

D.K. District Federation of Consumer Organization is a registered NGO formed on 2/11/2001, presently operating from 'shri harsha' 2-15-1329/2, Anegundi Road, Bejai, Mangalore -575004. This Federation was formed out of a desire expressed by a few likeminded and service oriented citizens residing in and around Mangalore with a view to mitigate the suffering of the people who are afflicted by invasion of their consumer right.

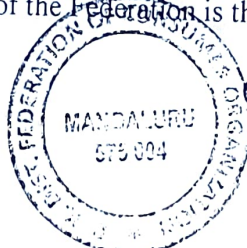

### About the federation

15 voluntary consumer associations in D. K. District are affiliated to this federation. Despite the efforts of the federation to spread awareness, the general public's response was lukewarm. However, with the Government of India's assistance to promote students of school and colleges in D.K. District by involving them in various consumers related activities by setting up Consumer clubs. During the last 5 years the Federation has successfully conducted the following activities:

- Formed 51 consumer clubs in 51 schools and colleges.
- Each consumer club has one co-ordinating teacher and the Federation conducts training programme for them at the beginning of each academic year.
- The Federation conducts one day consumer camp (workshop) for members wherein the students are imparted with consumer education. Students participate in Essay competition, singing, skit, quiz, drawing and speech competition followed by prize distribution.
- The Federation celebrated each year National Consumer DAY ON 24<sup>TH</sup> December and World Consumer Day on 15<sup>th</sup> March together with club members and the public.
- All programmes mentioned above are jointly conducted by the Federation and District Administration and Deputy Director of Food and civil supplies and Consumer Affairs of D.K. district.
- The media has given their support to the activities of the federation by providing adequate coverage with photograph in their respective newspapers.
- The Federation also conducts its activities on the very same principle in which the Consumer Protection Act came into being namely assisting people to get social justice either through the process of law or through negotiation and mediation process. A number of complaints have been and are being handled by the Complaint Cell of the Federation.
- As a support structure, the Government of India, the Ministry of Food Supplies and Consumer Affairs through Government of Karnataka have granted the Federation a District Consumer Information Centre which is presently housed at Taluk Panchayat premises on railway station road, Mangalore. The President of the Federation is the convenor of this Information Cell.

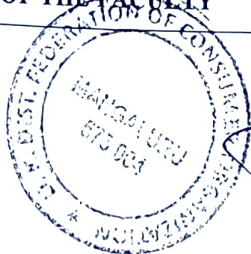

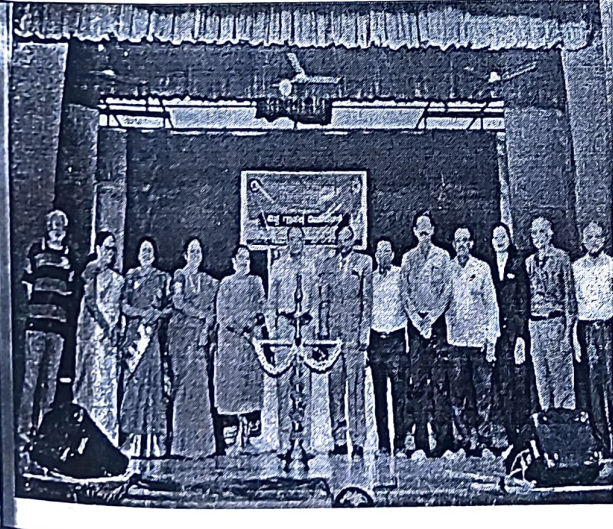

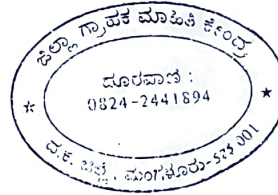
